Provincial Grand Lodge 100 Club Rules & Regulations

1. The subscription to the 100 Club for one number/share shall be £12 per year payable annually in advance. This will give members one number which will be placed in 4 draws (i.e. cost is £1.00 per month). Members may have and are encouraged to have multiple subscriptions.
2. Lodges, members, Family & Friends over 16 years can become a member of the 100 Club and you are encouraged to get family and friends to join. The 100 Club shall not be limited to 100 members. The more shares/numbers we sell, the bigger the prizes!
3. There is no provision to opt in/out on a month by month basis. The normal 100 club year will be June to May. Members joining after the start of the normal 100 Club membership year will be charged a pro-rata amount for the rest of the year until June and entered in the next available draw following payment.
4. A member is eligible for inclusion in the draw so long as the subscription for that quarter has been paid.
5. Each member is allocated a permanent number in the quarterly draw. This number shall remain the member's provided their subscription is up to date.
6. Members wishing to leave the 100 club should do so at the end of the club membership for that year. Refunds will not be given for people wishing to withdraw before the year end.
7. There shall be three prizes draw per quarter. The draw for each quarter shall be made as close to the PGL Committee Meetings as arrangements reasonably allow. Draws taking place during summer holiday period will be done whenever practical.
8. Quarterly prizes will be awarded according to membership of the 100 Club for that quarter as follows:
 - a. 50% of the quarter's net payments shall make up the prize fund. (50% first prize, 33% second prize and 17% third prize).
 - b. The remaining 50% of the net payments will be allocated to the PGL Border Youth Support Fund
9. The allocation of numbers and draw results will be available from **Bro. 10. The 100 Club administrators will make all reasonable efforts to pay prizes to the winners within a reasonable period after the quarterly draw.
11. The decision of the PGL Committee shall be final in all matters requiring adjudication.
12. The PGL Committee shall also have the power to amend or revoke these rules at their absolute discretion with such reasonable notice to the 100 Club members as is necessary.
13. Please either complete a download of the attached Bankers Order OR you can set-up a Standing Order online with the details of the PGL Sorting Code and Account Number as shown at bottom right of the Bankers Order Form.
